SCHEDULE "A"

The item known as The First Sikh Temple, situated on the land described in Schedule "B".

SCHEDULE "B"

All those pieces or parcels of land known as Lot 2 Section 35 DP 759113 and Lot 3 Section 35 DP 759113 in Parish of Woolgoolga, County of Fitzroy shown on the plan catalogued HC 3253 in the office of the Heritage Council of New South Wales.

SCHEDULE "C"

The First Sikh Temple, adjacent langar and flagpole

- 1. All general maintenance and cleaning.
- 2. All repairs, replacement and/or modification of fabric using like-for-like materials, appropriate colour schemes and maintaining existing location. Any unpainted elements and surfaces (eg. brickwork) are to remain unpainted.
- 3. Repair of damaged or deteriorated fabric that is beyond further maintenance, with new fabric which matches the original fabric in appearance, material, configuration and method of affixing.
- 4. Replacement of services that use existing service routes, cavities or voids or replaces existing surface mounted services.
- 5. All repairs, replacement, and/or modification of security and safety measures which matches the existing in scale and location.
- 6. All repairs, replacement and/or modification of emergency, safety, or interpretative signage which matches the existing in scale and location.
- 7. Temporary or permanent reuse of The First Sikh Temple and langar for purposes that support the religious and social use of the broader site.
- 8. Refurbishment of flagpole in line with the religious and social use of the broader site.

The new gurdwara (2019)

- 9. All general maintenance and cleaning.
- 10. All internal works to maintain condition and use.
- 11. All repairs, replacement, installation and/or modification of langar equipment and facilities that support the religious and social use of the broader site.
- 12. All external works to maintain condition and use if there is no significant visual or physical impact on The First Sikh Temple, langar and flagpole.

Landscaping, paths, driveway, carparking, fences and gates

- 13. All repairs, replacement and/or modification of paths, driveway and carparking if existing alignment is maintained.
- 14. All repairs, replacement and/or modification of fences and gates if existing alignment and style is maintained.
- 15. Any weeding, watering, mowing, pest control and fertilising necessary for continued health of plants without damage or major modification to layout, plant species or other significant landscape features.
- 16. Pruning (to control size, improve shape, flowering/fruiting and removal of diseased, dead or dangerous material), not exceeding 20 per cent of canopy of tree within a period of two years.
- 17. Removal of dead or dying trees if replaced by trees of same or similar species and in same location.
- 18. Excavation or disturbance of land for the purpose of exposing underground utility service infrastructure for inspection, repair, replacement or maintenance which occurs within an existing service trench and will not affect any archaeological relics. If any unexpected historical archaeological deposits and/or relics or Aboriginal objects are discovered, works must cease in the affected area(s) and the Office of Environment and Heritage must be notified immediately in accordance with the *Heritage Act 1977* (NSW) and the *National Parks and Wildlife Act 1974*.

Events

- 19. Holding of events as often as deemed appropriate that support the religious and social use of the broader site.
- 20. Installation of temporary structures (e.g. marquees, portable toilets, stalls, etc) for a period for events that support the religious and social use of the site and if there is no impact on the heritage significance of the broader site.
